What is the overall deductible?	In-network: \$6,900/\$13,800 (individual/family-\$6,900 per family member). Out-of-network: \$15,000/\$30,000(individual/family-\$15,000 per family member).	Generally, you must pay all of the costs from providers up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family deductible.
Are there services covered before you meet your <u>deductible</u> ?	Yes. Preventive care services are covered before you meet your deductible.	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. For example, this <u>plan</u> covers certain preventive services without <u>cost-sharing</u> and before you meet your deductible. Out-of-network: \$25,000/\$50,000(individual/family-\$25,000 per family member).	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services.
