<b>What is the overall <a href="#">deductible</a>?</b>	Indian Health Care Provider (IHCP) or with IHCP <a href="#">referral</a> and non-IHCP: \$0/\$0 (individual/family). In-network: \$6,250/\$12,000 (individual/family-\$6,250 per family member). Out-of-network: \$12,000/\$24,000 (individual/family-\$12,000 per family member).	Generally, you must pay all of the costs from providers up to the <a href="#">deductible</a> amount before this <a href="#">plan</a> begins to pay. If you have other family members on the <a href="#">plan</a> , each family member must meet their own individual <a href="#">deductible</a> until the total amount of <a href="#">deductible</a> expenses paid by all family members meets the overall family deductible.
<b>Are there services covered before you meet your <a href="#">deductible</a>?</b>	Yes. <a href="#">Preventive care</a> services are covered before you meet your deductible.
